As a Church of England school, many Governors are representatives of the church, by way of the St Alban's Diocesan Board of Education (DBE) or the Parochial Church Council (PCC). This is a requirement for all Voluntary Aided Church of England schools. Mrs Martin and Rev'd David Munchin both sit automatically on our Governing Body, as Headteacher and Incumbent respectively.

We also have two parent Governor positions - these are currently held by Stella Dunlop and Ashley Cordell. Stella is about to renew her Governorship for a second term and will take up the Local Education Authority category thus making available a Parent Governor position (details below.) We also have a staff Governor – this is Mrs Peters, our Reception class teacher.

Each of our governors has several 'link' areas of responsibility which are displayed on the Governor page of the school website. For example, Debbie May is our Safeguarding Governor.

As well as LPP and FRC, we have other committees which meet only occasionally, or when the need arises. Rachel Stringer is Chair of the Admissions committee. Rev'd David Munchin is Chair of the Complaints committee.

This vacancy is for the Finance and Resources committee, and we are looking for a parent with finance and/or accountancy experience.
